Title: Contract with Various Vendors for Asbestos Abatement, Lead Stabilization and Environmental Cleanup Projects (**\$67,200,000**) – Added 9.4.2024/Updated 9.17.2024

The Administration recommends that the Board of Education authorize The School District of Philadelphia, through the Superintendent or his designee, to execute and perform a contract, subject to funding, as follows:

Asbestos abatement, lead stabilization, and environmental clean-up projects and management of potential environmental hazards

Description:

Why is this contract needed?

These contracts will authorize environmental contractors to conduct the asbestos abatement, lead paint stabilization, and mold abatement that cannot be managed by in-house personnel.

How will the success of this contract be measured?

The approved firms' services success will be measured based on their workforce and the ability to meet project milestones and remain within the approved budget.

If this is the continuation of a contract, how has success been measured in the past, and what specific information do we have to show that it was successful?

This is the continuation of a contract. The success is measured by the immediate response capabilities to initiate and complete emergency asbestos abatement, on an as-needed basis, as well as ongoing needs for lead stabilization and mold abatement, throughout the District.
