Board of Education Public Meeting Minutes February 27, 2025

A public meeting of the Board of Education was held in hybrid format on February 27, 2025. Some Board Members, select staff, and some registered speakers participated in-person, while others participated remotely. The meeting was convened at 4:00 p.m by Reginald Streater, President.

Board Member Wilkerson shared that the Board remains committed to advocating for policies and investments that support student success and that they are closely monitoring the federal budget and impact of executive orders from the President and working with our legislative teams and partners to assess their potential impact on our students and families. Board Member Wilkerson asked those in attendance to help in advocating for our students by contacting their legislators to express their opposition to education cuts in the FY 2025 Budget proposal that would reduce funding for K-12 schools and programs that serve children.

Katherine Riley, district staff member, expressed disappointment in the board for not apologizing to students who were censored last year and asked the Board to uphold their sanctuary school policy.
