**Title:** Contract with GT Security for Physical Access Control Equipment, Services, Maintenance and Support (\$1,152,568)

### **Action Under Consideration:**

The Administration recommends that the Board of Education authorize The School District of Philadelphia, through the Superintendent or his designee, to execute and perform a contract, subject to funding, as follows:

**Purpose:**

Acquisition, implementation and ongoing maintenance of a centralized physical security access control solution for schools and administrative offices

**Start date:** 7/1/2025

**End Date:** 6/30/2027

**Compensation not to exceed:**

\$1,152,568

**Location:**

All Administrative Offices, All Schools

**Renewal Option:**

Number of options: 2; Duration of each option: 2 years

**Maximum Compensation authorized per option period:**

\$1,152,568

**Description:**

**Why is this contract needed?**

This contract is needed to enhance the physical security of the buildings within the District. The DNA Fusion security platform is a flexible and expandable system that allows for centralized electronic ingress/egress door control at any school or administrative building, remote monitoring and control of intrusion alarms, and integration with surveillance systems. Additionally, the DNA Fusion application interfaces with the District's new Oracle Human Resources system to automate the management of ID cards, and to allow all employees to use the Kronos time and attendance system.

**How will the success of this contract be measured?**

Success has been measured in the past by the deployment of a centralized access control system that integrates with the Kronos time and attendance system. Future success will be measured by further expanding this system to additional school locations.

School Safety and Capital Programs were involved with the creation of the initial project scope, as well as the scoring committee.
