Board Member Cubbage and Board Member Lam	1. Elevator modernizations improve ADA accessibility for school communities, directly supporting the District's Facilities Plan to increase the number of ADA-compliant facilities. This work helps address and reduce the deficiencies identified in previous Facilities Condition Assessments and the ongoing ADA Accessibility Assessment, ensuring equitable access for all students, staff, and visitors. By modernizing elevators, the District improves mobility, safety, and compliance with federal accessibility standards, fostering an inclusive learning environment. These upgrades are a critical step toward reducing barriers and enhancing facility equity district-wide.

The District is required by PDE to observe Christmas Day and New Years Day as days off within the academic calendar. We have also historically observed Christmas Eve as an additional religious holiday off for students and staff. In SY 2026-27, Christmas Eve falls on a Thursday and New Years Day falls on the following Friday, meaning that all week days in between those holidays are observed as days off, as well. Finally, stakeholders continually express that long holiday breaks and frequent days off are a top priority and key to preventing burnout and providing much needed rest throughout the year. In response to that input, we also included Wednesday, December 23rd as the first day of Winter Recess for the 2026-27 school year. This provides a total of 8 school days off for Winter Recess in that year, which is a reduction of 2 school days from the current school year's (2024-25) Winter Recess. 2. Beyond state mandated holidays, the District conducts extensive stakeholder engagement to determine which non-State mandated holidays are observed as days off on the academic calendar.
