By working with TPL, the School District has been able to install new schoolyard improvements that include the installation of new playground equipment, green infrastructure practices, artificial turf field surfacing, poured-in-place safety surfacing, landscaping, tree planting, fencing, basketball standard installation, and high-quality site furniture, and to repair and replace pavement.

TPL had been awarded Greened Acre RetroFit Program (GARP) grant funds by the Philadelphia Water Department (PWD) for stormwater improvements at Mary McLeod Bethune, Alain Locke School, and Amedee Bregy School.
