Why is this contract needed?

The District's GreenFutures sustainability plan emphasizes the need for students to access outdoor learning environments that integrate large-scale greening, green stormwater infrastructure, and nature-based learning. The Nature Conservancy worked

with the District to develop a grant application to the National Fish and Wildlife Foundation for greening and nature-based site improvements for the Benjamin B. Comegys School (“Comegys”), the Stephen Girard School (“Girard”), the Avery D. Harrington School (“Harrington”), and the Weir S. Mitchell School (“Mitchell”).
