Description:**Why is this contract needed?**

This authorization adds an additional 10 schools to the 20 schools in the Extended Day/Year initiative to have access to high-quality before and/or after school programs. In order to foster stronger, safer communities with District schools as the hub, students need opportunities to engage in learning enrichment activities beyond the regular school day. Under the common goals of both the City of Philadelphia and the District, expanding programming seats provides opportunities that allow a greater level of support and access to safe enrichment opportunities that support working families. Extended Day/Year programs support research-based approaches to enrichment, engagement, and student growth opportunities centered in student interest, social-emotional learning, skills acquisition, relationship-building, and more. Extended Day/Year programs will give students unique opportunities to explore their interests via enrichment activities that are aligned to academic, social emotional, and college and career focus areas. Furthermore, Extended Day/Year programming promotes general economic stability for families across the District by offering programs, both during the school year and in the summer.

How will the success of this contract be measured?

The City's Office of Children and Families utilizes industry-based measures from the National Institute of Out of School Time's *A Program Assessment System (ASAS)*, including the SAYO- *Surveys of Academic and Youth Outcomes*, to consistently monitor and support the quality of programs in alignment with the expectations of the contract.

We will be determining success by using the following metrics:

- Number of schools that participate in extended programming
- Total number of seats available across all sites.
- Quarterly data reporting on seat utilization. 80% or more of seats made available are sustained through the pilot year
- Percentage of students attending 90% or more of days at 20 participating schools ('23/24 SY baseline)

Additionally, enrollment and participation data will measure program engagement and drive continuous improvement efforts. The Office of Children and Families utilizes Cityspan to track and collect this data, and the contract will include opportunities to review that data to discuss efficacy and areas for growth.

Furthermore, the District's Office of Evaluation, Research, and Accountability will explore systems for analysis to examine overall program impacts on student progress in academics, attendance, and social-emotional well-being wherever possible.
