Description:**Why is this contract needed?**

The Department of Transportation Services is seeking to continue contracts with various cab and alternative vehicle vendors that provide transportation for students with Individualized Education Plans (IEPs) or other special education-related needs. These vendors offer essential transportation services when required by law or when determined to be the most cost-effective option. The contract covers a growing number of specialized routes—rising from 438 in 2019 to over 1,100 today—and is proposed to be increased by \$126,400,749 and extended through June 30, 2026.

The demand for transportation services for students with special education needs, as well as those requiring McKinney-Vento and foster care services, has more than tripled since 2019, growing from 438 to over 1,100 routes. A new RFP for these services has been issued; however, the timeline for proposal evaluation, Board approval, and contract execution means that new contracts are not anticipated to begin until July 1, 2026. Therefore, this extension through June 30, 2026, is essential to permit uninterrupted transportation services during the 2025 Extended School Year (ESY) and throughout the 2025–26 school year. To maintain accountability and high-quality service delivery, the District continues to evaluate vendor performance through quarterly audits and feedback from schools and families.
