Description:

Why is this contract needed?

IDEA (Individuals with Disabilities Education Act) requires that students with disabilities and students thought to be disabled receive special education evaluations using reliable, scientifically tested, research-based, and peer reviewed and verified special education evaluations tools and protocols. These student evaluations and assessments must be performed by a certified school psychologist. Based on this stringent criteria, the Office of Special Education and Diverse Learners selected the Contractors to provide District school psychologist with materials and on-line digital student special education testing kits, protocols and tools. The Contractors shall provide District school psychologists with individual licenses to access their on-line evaluation tools and protocols.

These digital testing tools include scientifically-based student assessments for all learning disabilities including specific learning disability, autism, emotional disturbance, Intellectual disability, ADHD, and multiple disabilities. The selected Contractors are world-wide leaders in special education testing protocols and evaluation systems. All of the Contractors' digital testing protocols and non-digital protocols are research-based and have been peer reviewed and tested. District school psychologists are trained in the Contractors' assessments and have utilized these testing protocols for many years to successfully evaluate students for disabilities.

School psychologists will be surveyed to determine satisfaction with the Contractors testing protocols and products.
