#### **Description:**

**Why is this contract needed?**

The Office of Environmental Management and Services requests approval of this contract for professional environmental testing and design services contractors to complete environmental remediation work. The District inspects approximately 50 buildings a month and these contracts are necessary to maintain District building programming and plan longer term projects.

This contract allows the District to comply with the Asbestos Hazard Emergency Response Act (AHERA), the National Emission Standards for Hazardous Air Pollutants (NESHAP), and the Philadelphia Asbestos Control Regulations and to address deteriorated lead-based paint surfaces and mold in school buildings. The professional services include testing, laboratory analysis, design services, site inspection, quality assurance, and regulatory compliance monitoring for asbestos, lead, and mold abatement and remediation projects. These contracts support ongoing capital improvement projects and day- to-day facilities management, maintenance, and operations activities. Evaluations of services are performed and overseen by the Office of Environmental Management and Services. Utilizing a pool of qualified firms is the most efficient way for the District to complete design activities to meet the project timelines.

The approved firms' services have been evaluated based on their ability to meet other project milestones and remain within the approved budget.
